- 1. Montse Fuentes, Executive Vice President and Provost, visited with Faculty Assembly. She discussed her vision for the University of Iowa to become a destination university, where students, faculty, and staff expect excellence from themselves, their colleagues, and classmates. She wants to improve graduation rates by increasing student support and reducing equity gaps, in part through the proposed Hawkeye First-Generation Initiative, GEAR UP program, and American Talent Initiative. She plans to expand experiential learning opportunities and find new ways to attract high ability students. Provost Fuentes stated the importance of reversing the decline in PhD student enrollment, for example by competing for training grants and recognizing faculty for mentoring doctoral students. She reviewed data regarding research productivity, including flat extramural funding over the past five years when the number of tenuretrack faculty, including faculty identifying as underrepresented minorities, declined. She noted the importance of recruiting and retaining outstanding faculty in elevating the University's profile and improving our AAU rankings, stressing the fundamental importance of diversity, equity, and inclusion to the pursuit of excellence in every area of our academic mission. She also answered questions from the floor, including discussion of the needs of first-generation college students, plans for experiential learning opportunities, improving outcomes in courses with high DFW rates, and retention of faculty.
