- 1. Lori Adams, Associate Professor of Instruction, Department of Biology, Secretary of Faculty Assembly, made several announcements:
 - a. CLAS faculty governance elections are open for voting today through March 4.
 - b. The Faculty Assembly Nominating Committee is seeking nominations of officers for 2020-2021, including Chair, Vice Chair/Chair-Elect, and Secretary. Faculty may send nominations to a Nominating Committee member by March 27.
 - c. CLAS Strategic Planning Listening Sessions will be held on February 28, March 24, and April 9 in the IMU. In addition, Sara Sanders, Associate Dean for Strategic Initiatives and Director of Diversity, Equity, and Inclusion; and David Cunning, Professor and Chair, Department of Philosophy, and Co-chair CLAS Strategic Planning Steering Committee, are scheduled to come to the Faculty Assembly meeting on March 25 for FA members to provide feedback on the draft CLAS Strategic Plan.
 - d. Bruce Harreld, President of the University of Iowa, will visit with Faculty Assembly at the March 25 meeting. Faculty Assembly members may send topics they would like President Harreld to discuss to a Faculty Assembly officer by March 4.
- 2. The minutes from January 29, 2020, were approved.
- 3. Abbie Katz, Associate Professor of Instruction, Department of Theatre Arts, presented a proposal for revision to the Certificate in Arts Entrepreneurship, previously approved by CLAS Undergraduate Educational Policy and Curriculum Committee. The program was launched as the Certificate in Performing Arts Entrepreneurship in 2008, and renamed in 2016 when the scope of the certificate was expanded. The new certificate structure will be tiered to ensure that students have a strong foundation in both their arts discipline

and business core courses before enrolling in the required Arts Leadership Seminar capstone. The proposal was approved.

- 4. Faculty Assembly adopted a motion, postponed from January 29, 2020, to approve with a correction "A Resolution In Support of Renewing Climate, Energy, and Sustainability Leadership at the University of Iowa", as adapted by Tyler Priest, Associate Professor, Departments of History and Geographical & Sustainability Sciences, from a similar College of Engineering resolution.
